## Case Examples

### *Response to Terrorist Attack*

A prestige hotelier suffered a fatal terrorist attack at one of their Middle Eastern resorts. BGN Risk carried out security reviews, risk assessments and liaised with law enforcement and other security agencies to establish the ongoing security risks faced by the client's estate across 11 high risk countries. We found our clients security preparedness to be proportionate and a healthy attitude to security was noted. This seal of approval from BGN Risk was used to negotiate favourable terms for their terrorism insurance renewal.

### *Planning a New Resort*

Security system engineers and architects developing a major resort in UAE had concerns that the technical aspects of the security designs would not fit with day-to-day operations. BGN Risk drafted a modified security strategy, having completed a detailed risk assessment and risk register, to ensure design standards were risk-based and proportionate. We led a working group to ensure end user needs were incorporated into designs: transparent planning, reduced costs and a methodology agreed on by planners and franchise owners prevented abortive work.

### *Halting Impacts of Crime*

A hotel in a European city experienced a series of night-time armed robberies. The attacks were increasingly violent and guest/employee safety was a major concern. After initial investigations and ruling out insider involvement, we recommended changes to cash handling procedures, altered back office arrangements to improve physical controls and worked with local law enforcement to sensitize them to conditions at the hotel. The criminals were apprehended and the new strategy created a secure environment for guests and staff, which immediately relaxed tension on site.
